Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the final arrangement is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for in full or in part, by or on behalf of the decedent.

Financial arrangements must be settled before the remains are cremated or in the event of a direct burial, before the remains are casketed.

## Professional Services:

Basic Service Fee of Funeral Director and Staff and Overhead.....\$ 595.00

Our basic service fee includes 24hour availability of staff to respond to the initial request for service: arrangement conference, planning selected tribute ceremony, securing vital statistics, coordination with crematory, other third parties, overhead costs such as, insurance, maintenance, utilities, equipment, administrative, secretarial and office expense as well as ordinary sheltering of remains (up to 72 hrs.). This fee for our basic services and overhead will be added to the total cost of the arrangements you select. (This fee is already included in our charges for direct cremation, direct burial and forwarding or receiving remains).

## Direct Cremation

Prices range is \$ 887.00 to \$1,595.00

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition material with or without outside covering and must meet the requirements of the Crematory. The container we provide is fiberboard.

Direct cremation with a minimum casket provided by us Gray Cloth covered flat top...\$1, 595.00

Direct cremation includes basic services of staff, overhead, transportation of remains to the crematory, prepare and complete required documents, cremation process, alternative container for the remains and a durable container (plastic) to hold the cremated remains.
